- Please use this form only if you are not taking summer courses or you will be enrolled for less than six credits during Summer 2010.
- Do not return this form unless you have submitted your 2010/2011 FAFSA.

- Summer work-study for periods of non-enrollment is a federal student assistance program based on financial need. To demonstrate financial need, you must complete and submit the 2010-2011 *Free Application for Federal Student Aid (FAFSA)* and have the results sent to the University of Sioux Falls (USF).
 - Summer work-study means that you will be a student worker at USF and that you will not be enrolled in summer classes.
 - Work-study positions may be full-time or part-time. Students cannot work more than 40 hours per week.
 - Students who intend to enroll for six or more credits may be eligible for part-time work-study. Please complete the **Summer School Financial Aid Request Form**.
 - To be awarded summer work-study, you must:
 - 1) complete this application
 - 2) have the results of your 2010/2011 FAFSA and any other required documentation on file with the Financial Aid Office.**You cannot begin working until these forms are submitted.**
 - You will be notified via a "Summer Work-study Award Letter" as to whether or not you are awarded Summer Work-Study for Periods of Non-Enrollment.
 - 1) Accept or decline the award in writing on the Award Letter that will be sent to you.
 - 2) Complete a Job Certification form with your supervisor.
 - **Students receiving summer work-study for periods of non-enrollment must intend to be enrolled at the University of Sioux Falls on a full-time basis during the Fall/Spring 2010-2011 academic year.**
 - Students receiving summer work-study are required to save a portion of the summer earnings for education expenses during the 2010-2011 academic year. **These savings will be treated as a resource (i.e. funds available) when determining your financial aid award for the 2010-2011 academic year.**
